GRANTEE SPOTLIGHT

Hampton Herd Expansion Project

The Beef Boosters Program was designed to provide locally grown beef to the Hampton Public School lunch program. It then became apparent that the link between students and where their food came from was not as present as one would hope it would be in a small, rural public school.

The Hawk Herd was started in Spring of 2019. This was a truly grassroots campaign, with a majority of the start-up costs with donations from community members and support from the Hampton Beef Boosters. Gates, feed bunks, and the current cattle shelter were built as shop projects by the Hampton Jr. High and High School students. By Fall 2019, there were cattle in the pens.

With the interruption in the Spring of 2020 by COVID, animals were not able to be taken care of at the Hawk Herd facilities, so were moved to local farms. This also set back the fundraising and expansion efforts for that year as well. However, the beef was processed by the Beef Booster Program for the 20-21 school year.

Fall of 2021 brought the birth of the Hawk Herd's first calve, a healthy bull calf. What made it even more wonderful and fulfilling was he was born the first day of school and all of the students were able to see a brand new calf, which many never had seen one that small.





William C. "Bill" Eloe was the high school basketball coach and YMCA director in Aurora during the early 1900's. He coached the first AHS basketball team to earn a Class F state championship in 1920. William contracted encephalitis and resigned from the district in 1927 due to the progression of his illness. William was a founding member of the Aurora Rotary Club.

Delight M. Eloe started teaching grades 3 and 4 at South Elementary School in Aurora in 1928 and retired as principal of West Elementary School in 1958. During that time she cared for her ill husband, raised five children, and maintained her community and church leadership activities.

William and Delight's son, Howard, created this award because of the support offered to his mother and family during his father's illness.

William C. and Delight M. Eloe Award for Inspirational Academic Leadership



With over 40 years of service with the Aurora Public School district, Randy Maahs is a true testament of a great leader. He started his career at the Aurora Elementary School as head custodian, and it wasn't long before he was a fan favorite. Not only did Randy serve as head custodian, he answered any call that was needed. Whether it be bus driver, snow remover, lawn mower or just simply helping with student activities, Randy was there to help. There has never been a more loyal employee. He really does make everyday a "Great day to be a Husky"!

Butch and Nancy Furse

Butch and Nancy have always cared deeply about giving back to the community.

Nancy, a native of Murray, NE, and Butch, born in Republic, KS, were married in 1959. They had their first two sons, Michael and Brent, while in Denison, IA where Butch was the Business/Advertising Manager of two newspapers. Their son B. Jay was born after Butch and Nancy moved to Aurora, NE in 1965.

Butch is a third generation newspaper owner and journalist. He and his father purchased the Aurora News Register in 1965 as copublishers. After the death of his father in 1972, Butch and Nancy continued to operate the Aurora News Register until they retired in 2000. After retirement, Butch's love of journalism and newspapering drove him to continue writing a weekly column for twenty years until the final 'Around the Square' column was published in 2020.

When their son, Brent, passed away unexpectedly at the age of 25 from a seizure, Butch and Nancy knew they wanted to carry on his legacy through a scholarship. The Brent Furse Memorial Scholarship Fund has awarded more than 25 scholarships in Brent's name since its inception in 1989.

In their continued dedication to giving back to the community, Butch and Nancy started the Ronald L. and Nancy Furse Charitable Fund at the Foundation in 2007. Their fund has impacted many organizations and programs over the past 16 years.

In 2023, their eldest son, Michael, passed away after fighting a courageous battle with cancer. His name is now beside his brother through the Brent L. and Michael C. Furse Memorial Scholarship Fund. Butch and Nancy have a strong faith and are proud of their middle son, B. Jay, who owns Cowart Door Systems and lives in Austin, Texas with his family.

"When Nancy and I arrived in Aurora, the Hamilton Community Foundation had just been created. My Dad was involved on the board and, over the years, the Foundation has become close to us. We feel it's our responsibly to manage our money, and the tax benefits through the Foundation allow us to have a greater impact on our community.
