We are grateful to the volunteers, organizations and donors who generously gifted their time, talent and treasure.

Over the past few years, there has been a shift in our sector to move away from the word "nonprofit". In such areas as health care, higher education, social services, and the arts, "nonprofits" are major service providers. The mission and daily work of our sector is about impact. History continues to demonstrate that social impact organizations are impactful everyday, but particularly when communities are experiencing challenges. The shift to social impact sector more accurately reflects the work of our community organizations.

We would like to thank our Board of Directors, community partners and individual donors who faithfully stepped up to address the challenges of the last year. There is much truth in the quote, "It takes a village."

COVID-19 Response Fund

The COVID-19 Response Fund, created March 31st, was designated to help address immediate needs in our community created by the COVID-19 pandemic.

Name a Life Insurance Designation

- Name HCF as the owner and/or designated beneficiary or partial beneficiary of a life insurance policy
- These gifts can reduce estate and income taxes

Direct a Retirement Plan Distribution

- Donors can give all or a portion of a retirement plan account
- Those over the age of 70 1/2 can make completely tax-free gifts transferred from traditional IRA and Roth IRA accounts without paying estate or income taxes
